## Beijing Capital International Airport Company Limited Announces September Traffic Data

[11 October 2012 - Beijing] Beijing Capital International Airport Company Limited ("BCIA" or the "Company", Bloomberg code: 694.HK) posted data aircraft movements of 47,480 and passenger throughput of 7,089,000 approximately in September 2012, representing an increase of 5.3% and 4.1% respectively, as compared with the same period of the previous year. The aircraft movements by domestic air routes recorded a rise of approximately 5.1% year-on-year. The aircraft movements by international, Hong Kong, Macau & Taiwan air routes were increased by approximately 5.7% year-on-year (The aircraft movements by foreign Airlines was increased by approximately 9.0% year-on-year). The passenger throughput by domestic air routes was increased by approximately 3.7%. The passenger throughput by international, Hong Kong, Macau & Taiwan air routes was increased by approximately 5.3% (The passenger throughput by foreign Airlines was increased by approximately 5.3% (The passenger throughput by foreign Airlines was increased by approximately 8.1% year-on-year).

For the first nine months of 2012, the accumulative total of aircraft movements was 416,980 and passenger throughput was 61,758,000 representing an increase of approximately 4.5% and 4.3% respectively, as compared with the same period of the previous year.

Beijing Capital International Airport Company Limited was incorporated as a joint stock company with limited liability in the People's Republic of China on 15 October 1999 to take over and manage the aeronautical operations and certain ancillary commercial businesses at the international airport in Beijing, the PRC. The Company was listed on the Hong Kong Stock Exchange on 1 February 2000. At present, the Company owns three terminals, three runways and completed facilities for serving passengers and handling cargos to operate and manage aeronautical and non-aeronautical businesses mainly in Beijing Airport. As at the end of 2011, there were 222 flight points at the Beijing Airport, including 116 domestic and 106 international and regional flight points.
